

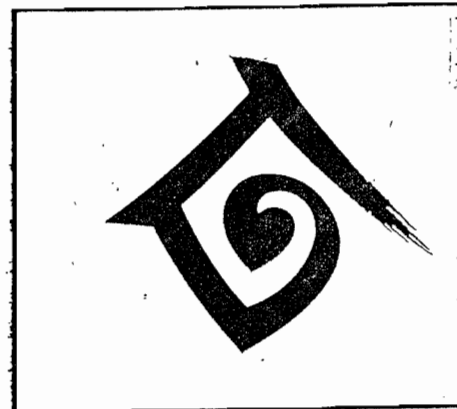
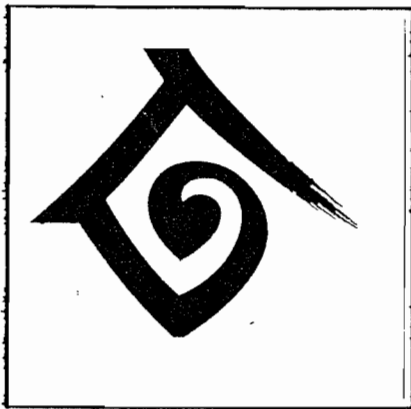

PRESIDENT'S REPORT 1993-1994

OVERVIEW

Another busy year - made possible by the dedication of all our volunteers; office staff, executive members and committee members. Our effectiveness has been increased by our continuing representation on other committees

We farewelled Stewart Barnes when she moved to Brisbane to live. Stewart was UNAA in South Australia for many years, serving as office manager and also office-bearer including secretary and Vice-president.

At our traditional Christmas party for volunteers we paid tribute to the involvement of Kath Fuller over many years; as Honorary Librarian and the 'fount of all knowledge'. Some of Kath's former associates were present to see Kath presented with a signed lithograph by an African artist which was used as a design for a UN stamp.

We record with sadness the death of Reverend Alan Gray a long-time faithful supporter of UNAA in South Australia. Alan used to bring in his "Peace" dollars on a regular basis for our continuing work. We will miss him.

The continued enthusiasm and efficiency of the United Nations Youth Association is an inspiration and encouragement to us all.

We provided philatelic material from World Federation of United Nations Association for display in the G.P.O. It consisted of original art works which were accompanied by the resulting First Day Covers and stamps.

We are looking forward to our move late in 1995 when the Torrens Building is made available to non-government organisations. We hope to be located close to the organisations we live with now - Amnesty, Global Education and Council of Churches.

Our continuing provision of two school packs per year enables resources relating to the UN and its agencies to be available in school libraries. Half of our grant from the Norman Percy Cole Foundation is used to support this work and the work with secondary and tertiary students.

The other part of the grant is used during Children's Week. Encouragement grants of approx. \$50 are given to groups to allow them to be part of special activities during the week -- often "Healthy Breakfast: and generations together activities.

Highlights of the year included two activities organised by the UNAA Status of Women Committee. The first was a public lecture by Professor Kathleen Mahoney who spoke on Gender Bias and Jusicial Education, drawing on her Canadian experiences. The second was the workshop on "Violence against Women- Rape; Why is she not heard?"

Representation on other committees

My membership of the Multicultural Forum provides information useful to the UNAA.

I continue to be Convener of the Human Rights Programme of UNAA and South Australian UNAA has a supportive responsibility. Our Human Rights reference material has been increased.

I commend Refugee Week to you - I represent UNAA on the hard working committee, which works with Mrs Lina Caporaso of Austcare in planning the week.

One World Collective We continue to share responsibility with Amnesty, Global Education and South Australian Council of Churches for the management and leasing of the the 1st Floor of 155 Pirie Street.

UNIFEM Breakfast committee organised a very successful breakfast on International Women's Day when over 300 women heard Dorinda Hafner speak. \$5000 was raised.

CHILDREN'S WEEK committee plans and coordinates activities during the week throughout the State.

We work closely with Women's International League for Peace and Freedom, the Volunteer Centre, Global Education, Dept. of Foreign Affairs and Trade, Australian International Assistance Bureau, Overseas Service Bureau, UNICEF, ICRA, Graham Smith Peace Trust, Amnesty, CAA and many others.

* Our speaker on UN Day October 24th was Professor Hilary Charlesworth who spoke on the topic "Has the U.N. forgotten the rights of women?"

* Dr Keith Suter covered a broad range of issues in his talk to members during a brief visit to Adelaide. He received good media coverage.

We have provided a great deal of information relating to both the Year for Indigenous Peoples (1993) and the Year for the Family (1994) We are preparing for 1995 -Year of Tolerance and 1996- Year of Eradication of Peverty and 1999 Year of Ageing.

FEDERAL CONFERENCE and Council Meeting

We were represented by Vonie Fee, Harriet Glen and Bev Hall;.

South Australia presented three resolutions;

- (1) That UN peacekeeping forces and other personnel should receive specialized cultural awareness training relating to the people they are going to work with prior to their arrival in a particular area so that the effectiveness of the UN's operations can be maximised.
- (2) That special operations training be provided to UN officials appointed to command positions so that their directives are effective and take into account the realities of the field situation and minimise risk to personnel.
- (3) That UNAA urge the Australian Government to raise the need for a review of the operations of corporations around the world with a view to establishing through a consultative process, if possible, a code of conduct for such international organisations to follow.

ANNUAL GENERAL MEETING was held on May 23rd; following the AGM there was an opportunity for members to visit the " Windows for the Future" exhibition.

Book ,Cards and Calendar Sales

Copies of "Just Literacy" continue to sell slowly but steadily. Our librarian also procures special orders from Hunters.

Resource Centre

Good progress has been made under the direction of our librarian Cynthia James in reorganising our library, discarding surplus material.

UNAA (S.A.DIV.) STATUS OF WOMEN COMMITTEE

The committee, comprised of representatives from affiliated women's organisations and individual members, has met regularly during year.

Its main activity was holding a weekend seminar in September 1993 entitled "VIOLENCE AGAINST WOMEN: RAPE - WHY ARE THEY NOT HEARD"

The workshop was attended by some 80 women. The keynote address was given by Jocelyn Scutt. Workshops followed during which the women shared their experiences, and explored measures needed to empower and support women survivors and changes that needed to be made to the judicial process and the law. The recommendations for Governments and agencies arose out of the despair and frustration felt by the women. They covered reporting, investigative, trial and sentencing aspects, but also included concern at the perception of women and of rape as a crime in society. Fundamental changes are needed from the playground to the High Court. Recommendations will be sent to the Law Reform Commission which is considering "Women's Access to the Legal System - Equality before the Law". Their interim recommendation that a National Women's Justice Commission be set up received support from the committee.

Other issues considered by the Committee included

- * representation to the Federal Government urging them to encourage the Japanese Government to take active responsibility in providing full restitution to all women involved.
 - * genital mutilation
 - * rape of women during war as a war crime
 - * representation to the new Minister for the Status of Women regarding the Women's Information Switchboard and the Women's Advisory Council and the Office of Status of Women
 - * Women's Suffrage Centenary programme
 - * issues to be taken to the Fourth UN Conference on Women in September 1995

UNAA (S.A.DIV.) PEACE AND DISARMAMENT COMMITTEE

This operates as part of the Coalition for Peace with Justice. It operates as an information exchange, a mutual support network and makes representations to government and departments.

The committee has concentrated its efforts this year on working with other activists to explore present situation of Peace Studies and Peace Education in South Australia. Aim is to promote units and courses into secondary and tertiary curricula.

The major success was to have released to us the text of a study guide for teachers, written in 1986 but never published. It is being updated with the aim of publication.

Committee has pursued the issue of conversion, working with A.P.C., WILPF, Centre for Labor Studies and UTLC. A leaflet was distributed and it is hoped that some research will eventuate

Petitions were circulated re World Court Project -- a Declaration of Public Conscience - seeking an opinion of legality of nuclear weapons.

Palm Sunday Peace Rally did not take place this year; emphasis will be put on Hiroshima Day observances.

We met with Kevin Clements on a brief visit to Adelaide.

Recently we have been working with other groups on the issue of Land Mines.

ANNUAL UNYA (SA) REPORT - July 1993 - June 1994

UNYA (SA) tries to fulfill its aims of raising youth awareness of global and international issues by organising a multitude of fun, social and educational events. These consist of monthly meetings, usually with a speaker, social and fundraising events, 2 State Conferences a year, plus a monthly newsletter that always includes an action page.

The speakers at our meetings included Heather Crosby, Momir Dacic, Janet McIntyre, Sam Knottenbelt and Tarnya van Dreil. Heather Crosby, from Women Against Demeaning Images (WADI), talked about the role of women in the media, censorship, freedom of expression and Women's Lib groups. Momir Dacic came from the Yugoslav Child Centre and spoke to us about the situation in former Yugoslavia and the reasons behind the crisis there. Janet McIntyre spoke about the street children in South Africa and the hardships they face. Sam Knottenbelt was from Urban Ecology and talked about Ecocities and the Halifax Project being developed here in Adelaide. Tarnya van Dreil represented Women's International League for Peace and Freedom (WILPF), speaking about their campaigns, such as the Filipino brides in Australia, as well as discussing what causes we as individuals feel passionately about. As you can see, the range of topics was diverse and extremely interesting.

The social and fundraising events included the Mad Hatters Tea Party in December, a Paper Making Day in January where we learnt how to make paper out of practically anything, a Quiz Night in April, and a showing of the film 'The house of the Spirits' coming up this June. A top priority is to enjoy oneself productively, and in that each event was a success. As for fundraising, there were varying shades of success.

UNYA (SA) aims to raise money to subsidise the delegates representing South Australia at the National UNYA Conference. To do so, we not only held the events already mentioned, we also sold chocolates desperately and held several 'How to Host a Murder' Dinners.

The 2 State Conferences were held in October 1993 and March 1994, both of which were very educational and enjoyable. We were lucky enough to have Kevin Clements speak at our October conference and Wayne Cristuado speak at our March one, both of whom outlined the challenges facing the UN today. As always we had a mock General Assembly at both, which are always remembered by participants as a definite highlight. The March conference also included a simulation game which dealt with the world of trading as we know it and its problems.

In the past year UNYA (SA) has continued to be active, and enjoyable while being educational. We are proud of this tradition and plan to keep it up in the future.
